Public Safety Update by Wood County Sheriff Kelly Cole

Marketing

• WCEDC Website Improvement Update by Kent Huffman: Mr. Huffman made a presentation to the board showing the design for the new public-facing website for Wood County. The rollout of the public-facing site will coincide with the rollout of a new, revamped WCEDC site as well as the implementation of the WCEDC's comprehensive strategy for marketing Wood County. Mr. Huffman detailed that the home page for the public-facing site will be complete and presented at the next board meeting along with further details of the EDC site and the marketing campaign as a whole. September 1 is the proposed date for the comprehensive marketing rollout.

Mr. Trahan detailed working with Commissioner Simmons and Mr. Lindholm on developing the guidelines and highlighted a local vendor incentive program contained within the guidelines. Motion by Commissioner Simmons to approve the guidelines as presented. 2nd by Mr. Callan; Motion carried.
- WCEDC Infrastructure Committee Broadband Initiative Letter of Support: WCEDC Infrastructure Committee Chair Lee Smith presented a proposed letter of support to the board for the Infrastructure Committee's county-wide Broadband Initiative seeking allocation of \$8.8 million of Wood County's American Recovery Plan Act funds to broadband and fiber-optic infrastructure around Wood County. Mr. Callan made a motion to approve the letter of support. 2nd by Mr. Steele; Motion carried.

<u>Chairman's Report:</u> Mr. Keenan reported that Wood County has been asked once again to sponsor the Bassmaster Tournament for 2022. The WCEDC plans to review the host contract with B.A.S.S. LLC and determine the maximum promotional value that can be negotiated from the agreement. Mr. Keenan also briefed the board on the Sabine River Authority's development of a multi-use pavilion on Lake Fork that will be used as the staging area for the Bassmaster tournament for 2022.
